PUBLIC INPUT

Mayor Ortiz, Jr. asked Council if they had any objections to listening to public input from those individuals that needed to speak on issues other than the Low

Altitude Navigation (LATN) Proposal at this time and all individuals speaking in favor of the Resolution on the (LATN) which opposes the low flying in our community would be addressed during Business Item two.

There were no objections from Council.

Ms. Dahlia Garcia, Councilor Romero's niece mentioned that a fundraiser was being held at the West High School cafeteria on October 2, 2010 from 11:00 a.m. to 3:00 p.m. for Councilor Romero to help with the family's various expenses and asked for the Community's support.

BUSINESS ITEMS

1. Appointment of a Mayor Pro Tempore for a six (6) month term, effective October 1, 2010 through March 31, 2011.

Councilor Feldman made a motion to nominate Councilor Moore to be the Mayor Pro Temp for the next six month term. Councilor Gurule-Giroń seconded the motion. Mayor Ortiz Jr. asked for roll call vote. Roll Call Vote was taken and reflected the following:

2. Approval/Disapproval of Resolution #10-78 stating an objection to the Low Altitude Tactical Navigation (LATN) Proposal in the City of Las Vegas.

Councilor Feldman asked the audience if those in favor of the Resolution opposing the Low Altitude Tactical Navigation Proposal would raise their hand. Councilor Feldman also asked if there was anyone in the audience that was in favor of the Air force low flying proposal.

All were in favor of Resolution 10-78 opposing the Low Altitude Tactical Navigation Proposal and a list of signatures were attached to show each citizen in favor of such resolution.

Mayor Ortiz, Jr. made a statement that he is in support of United States Armed Services and the need to train our armed service personnel, but it is his duty as the Mayor of the City of Las Vegas to protect the citizens of Las Vegas, therefore he is in support of Resolution 10-78.

Mayor Ortiz, Jr. entertained a motion. Councilor Moore made a motion to approve Resolution 10-78 opposing the Low Altitude Tactical Navigation Proposal. Councilor Gurule-Giroñ seconded the motion.

Councilor Feldman stated for the record that as a geologist and environmentalist he is sensitive to the environmental aspects and the effects it could have on the people of the community; he supports the military, but is not in favor of the low flying proposal.


