WATER ORDINANCE #12-13 **AMENDING SECTIONS 440-6 & 440-20**

SECTION 440-6 A. 1., 2. & 3. and B. 1., 2. & 3. – WATER RATES AND SERVICE CHARGES SECTION 440-20 E. – FIRE PROTECTION SERVICE

AN ORDINANCE AMENDING SECTION 440-6 A. 1., 2. & 3. and B. 1., 2. & 3. AND SECTION 440-20 E. OF THE CITY OF LAS VEGAS WATER ORDINANCE

WHEREAS, the water utility is currently in need of increased revenue to provide for capital improvements related to water quality, storage, conveyance and supply.

WHEREAS, the capital improvements were outlined in the Preliminary Engineering Report submitted to the City Council in September of 2011.

WHEREAS, in order to ensure the continued financial viability of the City's water fund, Red Oak Consulting provided recommended rate adjustments based on a rate study presented on July 11, 2012.

WHEREAS, the recommended rate adjustments will produce the following annualized revenue increases are recommended: Fiscal Year 2012-13 – 27.5%; Fiscal Year 2013-14 – 27.5%; Fiscal Year 2014-15 - 3.0% and Fiscal Year 2015-16 – 3.0%. All rates after FY 2016 shall be adjusted annually according to the Consumer Price Index, unless a new ordinance is passed declaring otherwise.

WHEREAS, the rate increase that was selected will be phased in to minimize the impact on customers and to charge customers based on actual volume usage.

WHEREAS, outside city limit residential and commercial customers will be charged 1.5 times the inside city limit rate based on the inside city limit rate schedule.

WHEREAS, the City supports the institution of low income assistance for qualified water customers.

WHEREAS, the City will administer a low income water assistance program for inside city limit customers that qualify for the Low Income Heating and Energy Assistance Program (LIHEAP). The qualification criteria and guidelines will match the state and federal guidelines. If a utility customer qualifies for LIHEAP they qualify for City assistance. A detailed award distribution formula and budget will be implemented through administrative regulation.

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF LAS VEGAS, NEW MEXICO, THAT SECTION 440-6 A. 1., 2. & 3. and B. 1., 2. & 3. AND 440-20 E. 1. & 2. OF THE WATER ORDINANCE BE AMENDED AS FOLLOWS:
