Upon completion, please mail this application, along with the appropriate license fee (see below) and the appropriate processing fee to: City of Las Vegas Community Development Department, attention Code Enforcement, 1700 North Grand Avenue, Las Vegas, New Mexico 87701. An application processing fee of \$100.00 for a residential building or \$100.00 for a commercial building must accompany this application.
