Councilor Martinez made a motion to approve the appointment of Councilor Michael Montoya and Councilor Marvin Martinez to the NMHU art selection team. Councilor Ulibarri seconded the motion. Mayor Romero asked if all were in favor. All were in favor.

Appointment of Councilor Michael Montoya to the Utilities Advisory Committee.

Luis Hernandez advised that he represents the NM Donor Services non-profit organization and the need for organ donation.

City Clerk Fresquez read a proclamation for "Donate Life Month".

Mayor Romero commended all City employees for doing their best and for all they do. Mayor Romero thanked the Public Works department for fixing potholes around the city.

## **COUNCILORS' REPORTS**

Councilor Casey discussed having Police patrol the area on Mountain View during parent drop off/pick up. Councilor Casey discussed her concerns regarding staff from the Health Services on 4th and Friedman and parents picking up their kids getting citations for being parked in the area for a short period of time.

Councilor Martinez advised that he received calls about potholes and issues with the lighting in the area of Independence Avenue.

Mayor Romero advised that he spoke with Jamie Aranda from PNM regarding lights not being replaced in certain areas.

Councilor Montoya thanked staff for bringing WeBe Racing to Rodriguez Park, West Las Vegas for allowing them to use their parking lot on Moreno Street, the Community Development department and Code Enforcement for all they do and

also the San Miguel County Commission for allowing them to use their County Chambers. Councilor Montoya advised that he attended the Hermit's Peak/Calf Canyon Fire presentation at Indigo Theater and people from FEMA advised that they are making changes and they are hiring more people so the process is faster.

Councilor Ulibarri thanked the Recreation Center and Public Works department for getting the fields ready for Little League and also the Police department for keeping the City safe.

Mayor Romero thanked the Council for working together.

Councilor Montoya asked about having one person handle the City website so it stays updated and he also thanked City Manager Montgomery for all he does.

Councilor Martinez thanked City Manager Montgomery for meeting with Council and for participating in events.

Councilor Ulibarri also thanked City Manager Montgomery for all his hard work.

Councilor Casey also thanked City Manager Montgomery for moving the City forward.

## **APPROVAL OF MINUTES**

Councilor Casey made a motion to approve the minutes from March 13, March 20 Special and March 20, 2024, with minor corrections. Councilor Ulibarri seconded the motion. Mayor Romero asked if all were in favor. All were in favor.

City Clerk Fresquez advised the motion carried.

## **PRESENTATIONS/POSSIBLE DIRECTION**

Luis Hernandez spoke on promoting and marketing the 4<sup>th</sup> of July Fiestas. Mr. Hernandez discussed a possible sponsorship program to help the 4<sup>th</sup> of July Fiestas and the economic impact that the 4<sup>th</sup> of July Fiestas has.

Mayor Romero discussed how the possible sponsorship could help the City with the 4<sup>th</sup> of July Fiestas.

Councilor Martinez discussed the amount of effort it takes from several departments to get the 4<sup>th</sup> of July Fiestas ready.

Councilor Montoya thanked Mr. Hernandez for being the Master of Ceremonies during the fiestas.

Councilor Ulibarri discussed the need for a Fiesta Committee and also thanked Mr. Hernandez for all he's done.

Mayor Romero asked what City Manager Montgomery's opinion was.

City Manager Montgomery advised that they should try to move forward with developing sponsorships to help celebrate what their successes are since the fiestas are important to the community.

Mayor Romero suggested giving the City Manager direction to work on moving forward with a sponsorship plan and asked Council if anyone objected.

## **BUSINESS ITEMS**

1. Request approval to Publish Ordinance No. 24-01 amending Gas Ordinance 06-08 and Section 255-11 of the Municipal Code.

City Manager Tim Montgomery advised there were discrepancies within the different utility ordinances, so contracted City Attorney Ambrosio Castellano reviewed the ordinances and incorporated state regulations and other principles into them so they are consistent.

Contracted City Attorney Ambrosio Castellano discussed what the City could do and when the City could take action for potential shut-off.

City Manager Montgomery advised that they want to prevent delinquent bills from becoming too large and cumbersome for customers.

Councilor Casey asked about renters who don't pay their bills and the property owners being stuck with the bill or vice versa.

Contracted City Attorney Ambrosio Castellano advised that it would be dependent on the landlord/tenant relationship and usually the tenant puts the utilities under their name so they wouldn't be able to open services at another location. Contracted City Attorney Ambrosio Castellano advised that if the landlord stipulates that they would pay the utilities on behalf of their tenant then they are assuming that responsibility and that would prohibit them from opening services at another property.

Councilor Casey advised that there was a correction needed on pg. 2, letter C, line 3, which stated "late payment fee in the even the customer" and it should state "late payment fee in the event the customer". Councilor Casey advised that issuance was misspelled on pg. 2, letter C, line 4.

Councilor Montoya discussed the amount of delinquent gas and water bills and advised that they could pass all the ordinances they want but they are not being followed.

Mayor Romero advised that the ordinances would eliminate putting people in a bind and not being able to catch up to a high bill.

Councilor Martinez discussed the consistency with having the ordinances the same and asked about a customer disputing a high bill.

Contracted City Attorney Ambrosio Castellano advised that it was stated in the delinquent notice that if a customer believes to have been overcharged or charged for services not rendered, they have a right to be heard and the City will evaluate their complaint.

Councilor Martinez made a motion to approve to publish Ordinance No. 24-01 amending Gas Ordinance 06-08 and Section 255-11 of the Municipal Code. Councilor Ulibarri seconded the motion. Mayor Romero asked for roll call. Roll Call Vote was taken and reflected the following:

City Manager Montgomery advised that the ordinance pertained to sewer.

Councilor Martinez made a motion to approve to publish Ordinance No. 24-02 amending Sewer Ordinance 05-12 and Section 340-53 of the Municipal Code. Councilor Ulibarri seconded the motion. Mayor Romero asked for roll call. Roll Call Vote was taken and reflected the following:

City Manager Montgomery advised that the ordinance pertained to water.

Councilor Martinez made a motion to approve to publish Ordinance No. 24-03 amending Water Ordinance 05-17 and Section 440-9 of the Municipal Code. Councilor Ulibarri seconded the motion. Mayor Romero asked for roll call. Roll Call Vote was taken and reflected the following:

4. Request approval to Publish Ordinance No. 24-04 amending Solid Waste Ordinance 10-20 and Section 361-10 of the Municipal Code.

City Manager Montgomery advised that the ordinance pertained to solid waste.

Councilor Martinez advised that a lot of time and effort was put into legal services and it's important that they move forward.

Councilor Montoya advised that he understood that there was time spent on legal services and didn't believe it was the direction of Mayor and Council. Councilor Montoya advised that they're going to be putting people in a bind.

Mayor Romero advised that he did not have any discussion about the ordinances and the Utilities Director had been working on it. Mayor Romero advised that previous City Managers never took her input.

Councilor Martinez made a motion to approve to publish Ordinance No. 24-04 amending Solid Waste Ordinance 10-20 and Section 361-10 of the Municipal Code. Councilor Ulibarri seconded the motion. Mayor Romero asked for roll call. Roll Call Vote was taken and reflected the following:

Mayor Romero voted yes and broke the tie.

City Clerk Fresquez advised the motion carried.

5. Request approval of Memorandum of Agreement (MOA) between the City of Las Vegas, San Miguel County and New Mexico Highlands University (NMHU) regarding the Gene Torres Golf Course.

City Manager Tim Montgomery advised last month Council approved to assist the Gene Torres Golf Course with \$60,000 for 2024 operations. City Manager Montgomery advised that there were additional items listed in the MOA to comply with the City's requirements such as providing golf access for high school

students and also NMHU reporting to Council so they could see the performance operations of the Golf Course.

NMHU Board of Regents Chairman Bill Garcia advised that they included two specifics into the MOA that Council asked for, the first one was NMHU providing free access to the golf teams of all the local schools and also providing Council with an update regarding the operations and the land development plan. Mr. Garcia advised that they need the City's help, support, input and guidance. Mr. Garcia advised that they would need to identify the utilities available to do map plotting and if it would be feasible. Mr. Garcia advised that they project approximately \$2 million per year benefit in tax increases to the community. Mr. Garcia advised that they appreciate the City's support that they have given in the past.

Councilor Martinez advised that he learned that the use of the Golf Course during the 4<sup>th</sup> of July Fireworks was not included in the MOA.

Mr. Garcia advised that everytime they change the MOA they cannot access the funds and that would mean another month that they won't be able to operate which is revenue for them. Mr. Garcia advised that they have cooperated in the past even though there was not an MOA and allowed the City to use the Golf Course for the fireworks. Mr. Garcia advised that they have never denied the City or any local community's request for the use of the Golf Course. Mr. Garcia advised that the management committee could agree to that type of use.

Aaron Flure with NMHU advised that he spoke with the Interim President and they have looked at the history and it was done in the past with a letter requesting the next two years.

Mr. Garcia advised that they would get a letter to the City affirming that there would not be charges to use the Golf Course.

Councilor Martinez asked when they anticipate the Golf Course opening.

Mr. Garcia advised that they estimate it opening the first of May.

Mayor Romero advised that they are partnering with Highlands University and when requesting the use of the Golf Course for the fireworks and the Ilfeld Auditorium for the pageant they were told it would cost \$5,000.

Mr. Garcia advised that they are open to meeting with him and working together.

Mayor Romero advised that he understands audits happen and since they had a MOA that would be the best time since they were assisting NMHU with money.

Councilor Montoya asked City Manager Montgomery if he was involved in creating the MOA.

City Manager Montgomery advised that he provided his input regarding the students having access and having the financial reporting taken to Council. City Manager Montgomery advised that it was also utilized with the County and was provided to him as a completed document. City Manager Montgomery advised that they did not have time to make adjustments.

Councilor Montoya voiced his concerns regarding the Management Committee and the Liability mentioned on pg. 4, letter H. Councilor Montoya asked why the City should be liable for something that happens at the Golf Course.

Mr. Garcia advised that the University was the owner of the Golf Course and they would be responsible. Mr. Garcia advised that the language in the MOA was boilerplate legal information that was also included in the last MOA and they only added the new requirements that that City asked for.

Councilor Montoya suggested that the MOA be for one year due to possible change in City Administration due to an election in November 2025.

Mr. Garcia advised that the MOA states that NMHU is to report to Council in a year and if they don't like the way it is being run or they don't like the Land Development, Council could decide not to provide additional funding.

Councilor Montoya advised that they should be working together and the City has always utilized the Golf Course during the 4th of July Fiestas and the Ilfeld Auditorium for the pageant.

Councilor Montoya made a motion to approve the Memorandum of Agreement (MOA) between the City of Las Vegas, San Miguel County and New Mexico Highlands University (NMHU) regarding the Gene Torres Golf Course for one year in the amount of \$60,000. Councilor Martinez seconded the motion. Mayor Romero asked for roll call. Roll Call Vote was taken and reflected the following:

City Clerk Fresquez advised that Tomika, LLC was requesting a transfer of ownership of Dispenser Liquor License with package sales only, which is currently owned by Franken Oil Company (Better Stop Convenience Store). City Clerk Fresquez advised that they went through the process of applying through the Alcohol Beverage Control Division and they got preliminary approval. City Clerk Fresquez advised that they are now asking for Council's approval and consideration. City Clerk Fresquez advised that all publication and zoning requirements were met. City Clerk Fresquez advised that it was published twice as per Alcohol Beverage Control.

Councilor Montoya made a motion to close the Public Hearing and reconvene into regular session. Councilor Ulibarri seconded the motion. Mayor Romero asked for roll call. Roll Call Vote was taken and reflected the following:

City Manager Montgomery advised that Interim Finance Director Chavez would have to see what the funding source was and if there were any stipulations.

Councilor Montoya asked if the maker of the motion could include the trailer to be on the auction.

Mayor Romero advised that the City Manager could work on adding additional items to the auction. Mayor Romero advised there was a first and a second motion.

9. Request approval of Amendment 4 to Lease Agreement between the City of Las Vegas and the New Mexico Department of Veteran Services.

City Manager Tim Montgomery advised that he reached out to the Department of Veterans Services due to the prior lease agreement expiring. City Manager Montgomery advised that they had to work with the General Services Division to have the agreement authorized by their attorneys. City Manager Montgomery advised that there was a note on the prior lease agreement that stated that the lease would increase by \$1,000 annually. City Manager Montgomery advised that the lease agreement would run through November 30, 2028.

Councilor Montoya made a motion to approve Amendment 4 to Lease Agreement between the City of Las Vegas and the New Mexico Department of Veteran

City Manager Tim Montgomery advised that RFP #2024-17 was awarded to Arch Consulting at the March 13, 2024 Council meeting. City Manager Montgomery advised that the contract would authorize payment to Arch Consulting Services. City Manager Montgomery advised that the contract does not specify a total budget amount and is based on \$90 per hour of services and the scope of the RFP was to cover grant monitoring of applications and administrative time to discuss their grants.

Councilor Martinez made a motion to approve the contract between the City of Las Vegas and Arch Consulting, LLC. Councilor Montoya seconded the motion. Mayor Romero asked for roll call. Roll Call Vote was taken and reflected the following:

11.Discussion/Request approval for additional funding in the amount of \$440,131.77 for an additional 1.5 inches of asphalt on the Legion Drive project.

Public Works Director Arnold Lopez advised that they had two alternates when they went out for bids, one was for 3.5 inches of asphalt and the other was for 5 inches of asphalt. Public Works Director Lopez advised that Desert Fox was the lowest bidder and funding only allowed for a 3.5 inch application of asphalt. Public Works Director Lopez advised that during construction they noticed the amount of heavy traffic that utilizes that road and they felt like 3.5 inches of asphalt is not sufficient to withstand the heavy traffic. Public Works Director Lopez advised that there is a weight limit on the road but traffic does not obey it. Public Works Director Lopez advised that they would place a total of 5 inches and the additional funding would cover the 1.5 inches.

Mayor Romero asked about the funding.

City Manager Montgomery advised that the increase in thickness of the road would be an investment for the City in how long it would last and the weight load it could take. City Manager Montgomery advised that there are limited funds that could come from a FEMA claim. City Manager Montgomery advised that the Finance Advisory Committee and the Finance department could look at the investments and the government investment pool. City Manager Montgomery advised that there are high percentage rates and the funds could be reimbursed from interests earned. City Manager Montgomery advised that in order to spend the money they would have to do a budget adjustment request and take it out of the general fund or bank account, which would increase the budget.

Interim Finance Director Chavez advised that 75% of the portion would be used from the Streets department and 25% would be taken from the General Fund. Interim Finance Director Chavez advised that he already had a BAR prepared for the Council meeting next week.

Councilor Montoya thanked the staff and advised that with the amount of asphalt placed on Legion Drive there shouldn't be potholes until 25-30 years. Councilor Montoya advised that a lot of money is spent on pothole patching and a lot of streets are in dire need of pothole patching. Councilor Montoya advised that they need to look at the budget to see if they could appropriate funding for other projects. Councilor Montoya advised that they were told there was limited funding this year from NMDOT.

Discussion took place regarding infrastructure in place across from Sierra Vista so they aren't having to tear apart the road on Legion Drive. Councilor Montoya made a motion to approve additional funding in the amount of \$440,131.77 for an additional 1.5 inches of asphalt on the Legion Drive project. Councilor Martinez seconded the motion. Mayor Romero asked for roll call. Roll Call Vote was taken and reflected the following:
