Items to be discussed: Resolution #22-53 Resolution #22-53 the City of Las Vegas is in need of making a budget adjustment in the 2022-23 fiscal year budget to include a transfer of budget from Code Enforcement to City Clerk in the amount of \$71,587, a transfer of budget from Code Enforcement to Community Development in the amount of \$43,494, an expense increase to Fund 641 Water Replacement in the amount of \$500,000, an expense increase to Fund 643 Water construction in the amount of \$500,000, an expense increase to Fund 646 Water GRT in the amount of \$1,000,000, an expense increase to Fund 647 Water Acquisition/Rights in the amount of \$900,000, a decrease to revenue in Fund 217 Special Legislative Appr. in the amount of \$228,928 and an increase to expense in the amount of \$119,437, and a revenue/expense increase to Fund 101 (Library) in the amount of \$200, Resolution 22-57 to adopt the Credit Card Acceptance Policy as per the Department of Finance & Administration, Local Government Division Requirements, Wildfire expenses/reimbursement request, September Finance Report, and September AP check listing.
