Last night we recieved reports that this dog was injured, possibly hit by a car.

He is a stray that many people have been feeding for quite some time, and when they saw his condition yesterday, everyone was worried sick.

Animal Control Officer Herrera with the LVPD was able to locate him and pick him up.

Once in our care we made arrangements for him to get medical care. He is currently at the Roadrunner Emergency Vet in Algodones.

The veterinarians believe he was most likely attacked by one or more other dogs.

His jaw is fractured. He has multiple lacerations to his face, and a fracture to one of his rear femurs, as well as one of his front legs but we cannot splint them because he has multiple puncture wounds in those areas, so the first step is to get the wounds to heal before we can address the fractures. He will be spending the night with the vet to start receiving fluids and antibiotics. We will await the call tomorrow to see if he can come home.

Unfortunately because this is a holiday weekend and all of our partner vets were unavailable, he needed to be taken to the emergency vet which is extremely expensive compared to our usual vet clinics.

Right now, his emergency care is estimated to be about \$3,700 (this is a high estimate for 48 hours of hospitalization but we most likely will not need him to stay longer than 24 hours.) His medical care would not be this costly if we did not have to use an emergency vet due to the holiday weekend. Once our vet reopen after Christmas, the costs will be much more affordable for us, but it was urgent he get in to ensure there was no internal bleeding.

We thought about humanely euthanizing, but the vet said the prognosis is good & with as sweet as he is, we are willing to fight for him, but we need your help.

Friends of San Miguel County Animals is accepting donations for his care on our behalf and will be helping pay these vet bills. Donations are going to be vital in ensuring this guy can receive the care he deserves.

We were told many community members were calling him Louie, so we have named him King Louie. 🖓 📸

This sweet boy just kept presenting more and more issues, making his prognosis go from good to not so good. He had infections, older wounds, and many more issues that were found after further inspection of his injuries. He was not doing well and was quickly taking a turn for the worst.

On Christmas Eve, after doing everything we could (within reason of course), we made the decision to end King Louie's suffering through humane euthanasia.

His medical bills are almost completely covered by donations made to Friends of San Miguel County Animals and Animal Advocates of Northern NM and were in turn donated to Louie's medical costs.
